

# Agreement to Provide Funeral Service Northern Virginia Hebrew Congregation 1441 Wiehle Ave, Reston, VA 20190

Under this agreement, as dated February 19, 2020, Jefferson Funeral Chapel, Inc. agrees to provide Northern Virginia Hebrew Congregation the following service package options for a period of 5 years through February 28, 2025.

### Service Description\*

*A funeral service in any Northern Virginia cemetery	\$2,990.00
*A funeral service at a synagogue followed by a cemetery burial service	\$3,490.00
*A funeral service at Jefferson Funeral Chapel followed by a cemetery burial	\$3,560.00
Funeral director performs removal from place of death, storage under	\$1,500.00
refrigeration, and securing the necessary paperwork in preparation for pick-up by	
another funeral director out of state.

## The following items and services are included in each of the above packages:

- The twenty-four hour, seven day, on call service to receive phone calls and provide staff to remove the body from the place of death and for immediate arrangements.
- Preparing and securing death certificate at doctor's time and place of convenience, securing burial transit permit, notifying Social Security Administration, and placing newspaper notices.
- Refrigeration of the body for the first seven days following death. Thereafter a fee will apply at \$60.00 per day.
- Use of the Funeral Director's Premises, 24/7, for tahara and shmira. Funeral Director will provide all customary equipment and supplies including: muslin shroud sets, Israeli earth, clay, protective clothing, and a shomer area.
- Bathing, dressing, and casketing the body when ritual washing is not performed.
- Providing funeral director and staff assistant for funeral services.
- Guest Register Book (valued at \$40.00)
- 50 Acknowledgment Cards (valued at \$30.00)
- Shiva Candle (valued at \$20.00)
- Vehicles necessary for funeral service (e.g. removal vehicle, vehicle to doctor's office, hearse to cemetery and vehicle to local health department)

\*The funeral is provided as a package. There will be no credit for services or merchandise provided above which are not taken by the patron, except as specified in this contract. Any merchandise not included or optioned in this agreement may be charged at the Funeral Home's then current General Price List, reduced by the package list value of such merchandise as it replaces. In no event will there be a separate charge for professional services. Beginning February 1, 2021, the price may increase \$100 per year. Additionally, all merchandise (e.g. casket, candles, muslin shroud sets, etc.) are potentially subject to price increases as reflected in wholesale price changes.
